



MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) is effective as of 1st day of October 2021 ("Effective Date").

BY AND BETWEEN






 - c. No additional cost of software, hardware is applicable to the Institution.
 - d. This MOU may be terminated by Institution (on the one part) or by the Edumerge (on the other) with immediate effect, if Edumerge (in case of termination by Institution), or Institution (in case of termination by Edumerge): (a) breaches this MOU and does not cure such breach within fifteen days of being notified of the breach and being called upon to cure such breach, (b) is subject to any insolvency resolution, bankruptcy, liquidation, receivership, or administration proceedings filed voluntarily or by a secured creditor or is subject to the appointment of any liquidator, administrator or insolvency resolution professional by any competent court or tribunal, or (c) admits to being,

- e. The expiry or termination of this MOU shall not affect any rights or obligations of a Party accrued prior to such termination.
- f. All provisions of this MOU that are by their nature intended to survive termination or expiry of this MOU shall survive such termination or expiry.

3. PRICING AND PAYMENT TERMS:

- a. Edumerge shall charge the Institution such amounts in consideration for providing Services under this MOU as set out in Appendix 1 of this MOU.
- b. The Institution will pay Quarterly in advance.
- c. The amounts in consideration for providing Services under this MOU as set out in Appendix 1 are applicable annually with an annual increment of 5% from academic year, 2022-23 onwards.
- d. Edumerge shall invoice Institution for the Services provided at the rates as set out in Appendix 1 of this MOU. Subject to timely receipt of the invoices the Institution shall pay the service charges to Edumerge on a quarterly basis to a bank account designated by Edumerge in advance for each quarter.
- e. Taxes will be charged at actual, if applicable.

4. Confidential Information:

- a. The recipient of any Confidential Information (as defined below) will not disclose such Confidential Information except to affiliates, employees, agents and professional advisors who need to know the same and who have agreed in writing (or in the case of professional advisors are otherwise bound) to keep the same confidential. The recipient will ensure that all such persons use such Confidential Information only to exercise rights and fulfill obligations under this MOU, and use reasonable care to protect the same. 



10. **Severability:** The clauses and sub-clauses contained in this MOU are severable and any illegality, invalidity or irregularity, inconsistency or repugnancy of any clause/sub-clause in this MOU shall not in any way affect the legality, validity or regularity of any other clause/sub-clause.
11. **Jurisdiction and dispute resolution:** This MOU will be governed by and construed in accordance with the laws of India, and subject to the following provisions on arbitration, any disputes relating to or arising in connection with this MOU will be subject to the exclusive jurisdiction of the courts in Belgaum, India. Any dispute, claim, difference or controversy arising out of or in connection with this MOU, including any question regarding its existence, operation, termination, validity or breach thereof shall be referred to and finally resolved by arbitration in accordance with the provisions of the Arbitration & Conciliation Act, 1996, and such arbitration shall be conducted by the Indian Institute of Arbitration & Mediation, in accordance with its Arbitration Rules (i.e., the IIAM Arbitration Rules) for the time being in force. The number of arbitrators shall be one. The place of arbitration shall be Bangalore, and the language of the arbitration shall be English.
