

- 2. Meeting Notice by register post was sent to Dr. Bannigol S. K. RGUHS Nominee for the G.C. of our Institute on 07-04-2017. Dr. Jagadish also telephonically informed regarding the meeting to Dr. Bannigol on 18/04/2017. Dr. Bannigol, said that he would inform us regarding his attending the meeting. There was no further correspondence from him & Dr. Bannigol was absent for the meeting.
- 3. President Maratha Mandal, Smt. Rajshree Nagaraju shared her ideas on formulating the guidelines for CRL at our institute. She suggested that Dr. Bhat & Dr. Diwan should lay down in detail the protocols & SOP's for the lab. President also suggested that the UG's & PG's should be explained regarding the importance of CRL & they should be taken around the Lab once it's ready. Discussions' regarding Dress code (Scrubs & Headcaps) for lab was undertaken & Assignment of Duties to the lab personnel's have to be laid down, President stressed.
- 4. Dr. Jagadish bought up idea of having 3-6 months Internship program in CRL. President Mam appreciated the concept & said to work on the guidelines for the Program.
- 5. Dr. Ramakant S. Nayak appraised the council members regarding the various grants received by CRL & how is it being utilized currently.
- 6. Dr. Ramakant S. Nayak informed the council members of the budget allocation to library for the years 2016-17 & 2017-18. He suggested that revamping of digital section of library in sync with current needs will be beneficial. Revamping Networking of all the computers which are enabled for access to e Library of University was suggested. Quotation for the same was put forth.

Discussion was held for purchase of equipment and dental chairs for the academic year 2019-20. The requirements for the institute as per the new MDS norms and BDS Inspection proforma was discussed. A tentative budget/quotations of approximately Rs. 70 lakhs was put forth. It was decided to buy the various equipments in 3 phases. Discussion were held and deliberated and finally concluded to purchase equipment and dental chair worth 28 lakhs . in the first phase (Quotations procured for the same were discussed)

Annual Budget for the library, required books and journals were discussed. Total No. of 40 journals will be procured. Quotations received for the same was discussed and approval of Rs. 26,24,000/- was sanctioned for Journals for 2019-20. 32 International and 8 national journals were finalised to be procured.

- Rs. 20 Lakhs cheque to be released as advance.
- ii) Balance 6 lakhs to be released by December 2019

Discussion was held for procuring equipments/glassware for medical departments as per BDS inspection proforma for the year 2019-20. The final sanction of 9,60,000/- was given. It was decided to purchase equipment/glass wares worth 5 lakhs immediately followed by purchase of remaining equipments in the coming year.

Principal appraised the council member regarding various grants received by CRL and how the materials are being utilised currently.

Discussion for Hospital attachment was done. Draft of Memorandum of Understanding (MOU) with Lakeview Hospital was discussed. It was decided to pursue the same with Lakeview hospital and once draft approved by both parties, a formal MOU will be signed.

Board member Mr. Nageshrao S Zangruche suggested about the development and beautification of campus, wherein Principal Sir showed the project plan of the entire campus. Suggestion from the Board members was taken. Water and bore well problems were discussed and solution for the same suggested by President Madam

It was decided to form a Condemnation Committee to deal with Condemnation of instruments/equipments which are spoilt./not working/ cannot be replaced. As per instruction of President, Maratha Mandal two nominees of the Management, Principal, Vice Principal and all the dental departments HOD's, Mr. B J Patil store incharge and Mr. Pramod Jadhav, Office Suptd would be part the Committee along with one member of maintenance department. It was decided that the committee decisions for condemnation the equipments/instruments will be final. A separate register of the committee decisions will be maintained.

The members were apprised of our BDS students representing University in Table Tennis tournament. The Governing Council members congratulated the students for their achievements.

The meeting was concluded with vote of thanks.

MINUTES OF MEETING

The Governing Council meeting started with a welcome to all the Members by The Principal. The Governing Council meeting started in the presence of President, Maratha Mandal Smt Rajshree Nagaraju, Principal Dr Ramakant Nayak, Vice Principal, Administrative Incharge and Academic Incharge on 03-09-2020.

All Covid appropriate Precaution were followed during the meeting.

The meeting commenced with the approval for purchase of consumables and non-consumables for the academic year 2020-2021 and a budget of Rs 40, 00,000 was approved for purchase of the consumables and Non consumable items. The Principal could procure the materials as and when required.

Principal informed the council members the various SOPs that were planned for treating patient due to the ongoing Pandemic. A uniform dress code was also planned for the students of the institution which was approved during the meeting.

The Council members were also appraised about the online teaching learning methods followed by the institution during the pandemic.

The Annual Budget for the library, required books and journal were discussed and a total of Rs 35,00,000 was sanctioned as the annual budget for the Library. The various quotation that were received was discussed and Rs 14,00,000 worth books, journal and other expenses were sanctioned in the meeting.

Principal also put forth the material requirement for the Central Research Laboratory and a sum of Rs 20,00,000 only was granted for the same. The procurement of these materials was to be carried out as per requirement.

Due to the ongoing pandemic idea of setting up a Covid testing lab was put forth in the meeting to which the response of the board member was positive. President Madam informed Principal to chalk out a plan for the same and also mentioned to include Dr Kishore Bhat in the planning and implementation.

President Smt Rajshree Nagaraju, President Maratha Mandal also put forth the idea of Green revolution and suggested about setting up of a Sclar Power plant and rain water harvesting plant. The office staff was informed to get the tenders for the same.

President Madam also informed the members that a Sewage treatment plant will be setup in the college campus according to the norms of the Pollution Control Board. A budget of Rs 14,00,000 was sanctioned for the same.

Principal also requested madam to install a lift in the college for the betterment of the patients. A budget of Rs 12, 00,000 was proposed for the same.

MINUTES OF MEETING

The Governing Council meeting started with a welcome to all the Members by The Principal. The Governing Council meeting started in the presence of President, Maratha Mandal Smt Rajshree Nagaraju, Principal Dr Ramakant Nayak, Vice Principal, Administrative Incharge and Academic Incharge on 13-09-2021.

The meeting commenced with the approval for purchase of consumables and non-consumables for the academic year 2021-2022 and a budget of Rs 50, 00,000 was approved for purchase of the consumables and Non consumable items. The Principal could procure the materials as and when required.

The Annual Budget for the library, required books and journal were discussed and a total of Rs 35,00,000 was sanctioned as the annual budget for the Library. The various quotation that were received was discussed and Rs 15,00,000 worth books, journal and other expenses were sanctioned in the meeting.

Principal also put forth the material requirement for the Central Research Laboratory and a sum of Rs 30,00,000 only was granted for the same. The procurement of these materials was to be carried out as per requirement.

President Smt Rajshree Nagaraju, President Maratha Mandal also put forth the idea of establishing a Biogas plant in the college campus for which she requested the Office Head to inquire about the quotation for the same. She also sanctioned Rs 1,00,000 for the same.

Board Member also suggested about water harvesting projects. President Smt Rajshree Nagaraju lauded the idea and instructed the college engineer to finalize the sites for the project and Principal was asked to oversee the preparations for the same

Principal also briefed the management about the Hospital based software that is a value addition for the institution. President Smt Rajshree Nagaraju sanctioned a sum of Rs 5,00,000 for the same. She also instructed that training Programmee for the same should be arranged for the staff members. Madam also instructed The Principal to also look into other software's for the admistrative and academic purpose also.

Principal also informed President Madam and sought permission to display the college event and achievement on the Display boards at the entrance on the college for the common public to view.

Vice Principal also suggested to opt for concessional treatment rates for the patients. And also sought permission to print the same in newspapers.

Principal also sought permission from President Madam for recruiting new staff member in the various departments as per the new DCI requirement. (Notification – September 2017)
